



Five Year Warranty and Limited Ten Year Warranty

Solid State Lighting LED (Light Emitting Diode) 50,000 hour rated DLC products

Applicable Models – All EarthTronics 50,000 hour rated, DLC Listed LED Fixtures, T8 LED lamps and High Lumen E39 base retrofits only.

Standard Five Year Warranty: Five (5) years from the date of purchase based on normal recommended usage in accordance with applicable specification sheets, installation instructions and packaging details. Warranty is subject to terms and conditions listed below. EarthTronics, Inc. warrants that each of its LED lighting fixtures that are purchased while this Warranty is in effect will be free from defects in materials and workmanship for five (5) years. The Warranty Period runs from the date of original purchase from EarthTronics, Inc. or its authorized distributor.

Extended Limited Warranty: 10 years based on normal recommended usage (based on 10 hours average use per day/7 days per week) in accordance with applicable specification sheets, installation instructions and packaging details. Warranty is subject to terms and conditions listed below. EarthTronics, Inc. warrants that each of its LED lighting fixtures that are purchased while this Warranty is in effect will be free from defects in materials and workmanship for ten (10) years. The Warranty Period runs from the date of original purchase from EarthTronics, Inc. or its authorized distributor.

Terms and Conditions

1. This Warranty is extended only to the original purchaser of the Product from EarthTronics, Inc. or from an authorized EarthTronics distributor, and is otherwise void.
2. This Warranty shall not apply to any Product which is used, installed, operated or maintained in violation of any applicable standard, code or instructions for use, including, without limitation, those contained in the Standards for Safety of Underwriters Laboratory, Inc.
